Mayor Pacheco welcomed Susan Haines, of the Wyoming Society of the United States Daughters of 1812. This organization requested proclamations in honor of Star-Spangled Banner Day and Constitution week. Mayor Pacheco read one of the proclamations and presented them to Ms. Haines.

Mayor Pacheco then introduced Laurie Urbigkit, Government Affairs Director of the Wyoming Realtors. Ms. Urbigkit invited Councilmembers to attend the Wyoming Realtors state convention next week, which will also be a celebration of the Bishop House and the anniversary of the National Fair Housing Act.

Dennis Steensland, 533 S. Washington, inquired about the new Council agenda sequence and requested several items be finalized by Council.

Moved by Councilmember Hopkins, seconded by Councilmember Walsh, to, by minute action: establish September 18, 2018, as the public hearing date for the consideration of fiscal year 2017-2018 Community Development Block Grant Consolidated Annual Performance and Evaluation Report; and new hotel guest registration ordinance. Motion passed.

Mayor Pacheco opened the public hearing for the consideration of the zone change of Lots 1-8 inclusive, Block 1, North Burlington Addition, located at 143, 145, 159, 169 West K Street, from R-3 (One to Four Unit Residential) to R-5 (Mixed Residential).

City Attorney Henley entered two (2) exhibits: correspondence from Liz Becher to J. Carter Napier, dated August 24, 2018 and an affidavit of publication, as published in the <u>Casper-Star Tribune</u>, dated August 20, 2018. City Manager Napier provided a brief report.

Speaking in support was Leon Webber, on behalf of the owner/applicant.

There being no others to speak for or against the issues involving the zone change, the public hearing was closed.
